Selectmen's Meeting Minutes 09-28-2015

Present: 1<sup>st</sup> Selectman-Galen Larrabee, 2<sup>nd</sup> Selectman-Jeffrey Stevens, 3<sup>rd</sup> Selectman-William Ingraham (arrived at 6:55PM), Town Clerk Carol Hamblet, Treasurer Dorrit Emerson, Jerry & Liz Sullivan from Sullivan's Waste Disposal, Lily Joy of Greater Pen Bay Driving Academy, CEO & Cemetery Committee Chair-David Schofield and Hans Schmidt

Meeting called to order by 6:05PM by Galen Larrabee.

Motion, Second and Vote 2-0 to accept agenda as written.

Motion, Second and Vote 2-0 to accept minutes of September 14, 2015 as written.

Jerry & Liz Sullivan were present to discuss the costs of curbside pickup. The number of stops has been set unofficially at 390 for January 1, 2016. The current contract runs through December 31, 2016.

Lily Joy of Greater Pen Bay Driving Academy requested permission to hold Driver Education classes at the town office. This would involve 6 sessions a year @ 10 sessions each to be held 3:30 to 6:30PM on Tuesday, Wednesday and Thursdays. Motion, Second and Vote 2-0 to approve one session on a trial basis with a fee of \$10.00 per student. Flexibility will be needed for certain times such as Election Day. Lily requested that the town draft a letter to go to the Bureau of Motor Vehicle stating that permission to hold the classes has been granted by the town.

David Schofield, CEO, gave an update on the land use violation case at 121 Kenney Road.

David Schofield, Cemetery Committee Chair, said that posts will be set in the Kelsey Cemetery tomorrow. The wood at that cemetery will go to Knox residents.

Hans Schmidt submitted a petition calling for a special town meeting and the Registrar of Voters has certified that a sufficient numbers of signatures was obtained. Motion, Second and Vote 3-0 to call a Special Town Meeting on Tuesday, October 13, 2015 at 6:30PM. A warrant will be drawn up by the Town Clerk with the specific wording that is on the petition.

Hans Schmidt also had suggestions for efficiency improvements that he will submit in writing to the Board.

Motion, Second and Vote 3-0 to accept the General Assistance Ordinance Appendices A-D 2015-2016.

Tax Issues were discussed and further research needs to be done by the Board.

An update was given on the land use violation case at 464 Kenney Road.

Correspondence was reviewed.

Motion, Second, Voted 3-0 to pay the EMA/Fire Chief his yearly salary.

The grading of roads was discussed.

Treasurer's Warrant was reviewed and signed.

Motion, Second and Vote 3-0 to adjourn at 8:30PM.
