

Selectmen's meeting minutes for 05/07/2024

In attendance: Willie Ingraham, Joshua Larrabee, Jeffrey Stevens, Ivy Larrabee, Jacky Binette,

Meeting called to order at 6:05pm by Joshua Larrabee

Previous meeting minutes were reviewed. Voted all in favored for approval.

The warrants were reviewed and signed.

Jacky's Agenda:

1. Personal property declaration deadline has passed. She asked the Selectmen to make a decision on the accounts that were not declared. Should we bill them or go off personal knowledge as to who has a business or not? Josh has the list, and the Selectmen will review and decide.
2. Jacky has found a few businesses in town that do not have accounts for personal property. She will be creating new accounts and reviewing.
3. We need to reach out to the accounts that did declare as a business and get BETE applications filled out. Ivy will put these accounts in a spreadsheet and add phone numbers for Jacky to call.
4. Revision Energy has been asked to provide asset information in case there is an audit down the road to cover our submitted BETE costs.
5. CMP has not declared yet.
6. May 21st Jacky will be meeting with John Miller for our yearly mapping update.
7. Two RE accounts have applied for Open Space exemptions. Accounts RE 457, and RE 345. Jacky has to do more research on these before making a suggestion for the Selectmen.

Ivy asked the Selectmen to review road signs and plan a time for these to be put out.

We received our Town Office water test results. We have satisfactory water for consumption. We will be testing yearly as the Office is the towns emergency meeting place.

Eastern Salt Company has given us a company statement. They have bought out Harcros, where we have previously purchased our winter salt. We have filed this for review for fall.

We received a quote for TRIO Sketch. Contessa wants to negotiate the price as the town paid for TRIO web in 2022 and they were unable to follow through with their end of the commitment. We have not received any refund for that purchase.

The Selectmen signed the three year contract for Bolsters curbside rubbish removal.

Ivy made a Farm Share list for 2024. The Selectmen reviewed and approved this list. They added two more people to it.

Jen Buttery called and left a message about her mailbox on the Sutor Road. She stated she has been getting notices about her mailbox since the road was redone. The Selectmen stated that if the mailbox is too low now it is up to the property owner to repair this issue for USPS. Ivy will call back 05.08.2024.

Josh contacted Jennifer Work about road grading. She said they are short staffed currently but plan to have it done in the next couple weeks.

Residents have complained about some pot holes on Abbott Road, Knox Station Road, Oaks Road, and Curra Road. Josh will work to complete this and use hot top to ensure it lasts longer than cold patch. All three Selectmen approved this decision.

PP55 has requested a reduction in the value of his personal property account. The Selectmen declined changing this.
